

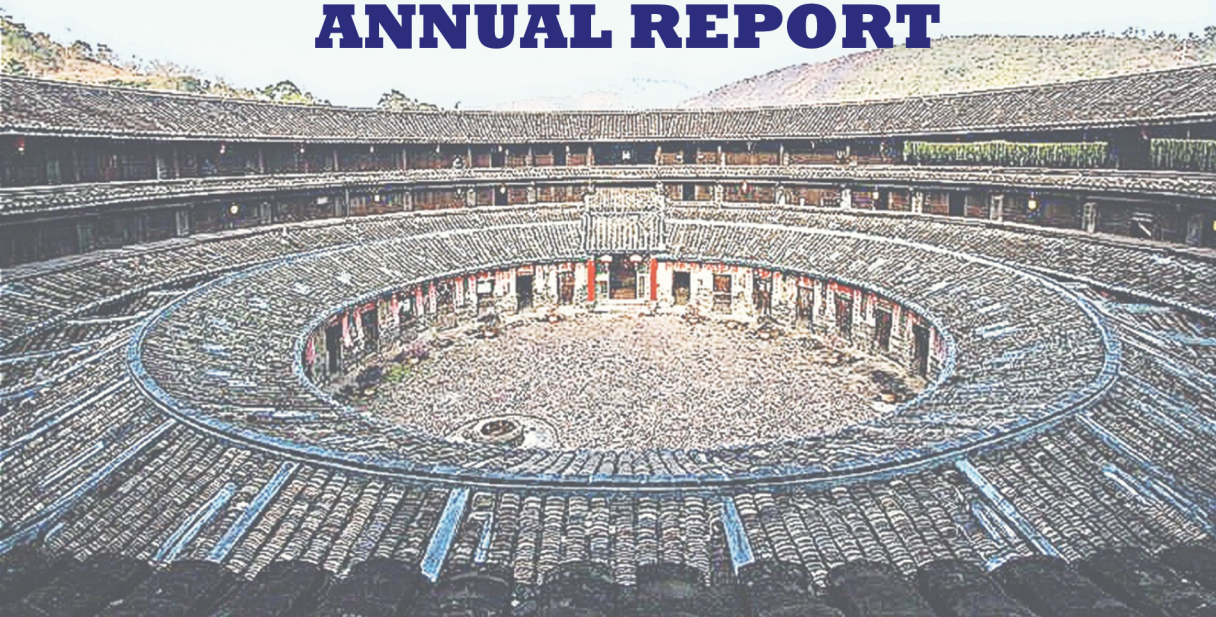



### 1. 大会主席杨博耀致词

各位理事、会员乡亲，大家早上好。非常感谢今天踊跃出席【2022年度常年会员大会】的会员乡亲们。

今天会馆和回春馆安排在同一天召开会员大会。希望往后，我们能将两馆一社整合为更强大的团体，互相联合一起办活动，使各方面能更进一步。

本人代表理事会由衷感谢各位热心的乡亲，时刻关心本馆会馆发展。同时也希望各位会员乡亲往后能够继续支持及参与本馆的活动。谢谢大家。



### 2. 复准前期会议记录（2021年12月11日）：

由张绍志提议，李启柱附议，一致通过接纳前期会议记录。

### 3. 接纳2021年会务报告：

张荣华今日不见关帝像，询问关帝像目前在何处？

主席杨博耀回应，本馆的关帝神像已经有超过70年的历史，关帝像附于回春馆中，属于回春馆的产物。经过多年岁月，关帝金身脱落，因此经谐街关帝庙介绍，送往峇株吧辖找专业人士重贴金箔，重新修复。由于重新修复金身必须在清明节以后才能处理，因此在五月份才将金身送去。由于修复须时，因此在此次会员大会前尚未能将关帝金身迎回，但会在关帝诞前将金身迎接回来。

张荣华希望本馆在关帝诞以前将关帝金身迎回。

赵绍田表示今年仅收到大会通知书及财务报告，但没有收到会务报告，因此询问理事会为何今年没有将会务报告邮寄给会员。

杨博耀指出，早在 2015 年的常年会员大会中已经通过议案，非选举年仅寄出大会通知书及财务报告，以节省邮费及印刷开销。

赵绍田认为应将完整的会务报告寄出，因为这是会员的基本权力。如果没有寄出会务报告，那么没有出席大会的会员就无法了解会务，因此建议将所有会务报告寄出。

杨博耀提醒，若会员有任何提案应在大会前七天来函提出。非选举年仅寄出大会通知书和财务报告是已经在会员大会中通过的议案。本馆的收入靠的是租金和银行定期存款利息，而这两年的利息也越来越低，因此认为能省则省。若会员们觉得有需要寄出会务报告，可以再商议。但本馆每次会员大会时所寄出的会务报告，每年至少有两百封是被邮局打回头的。如果会员们真的如此关注本馆会务，理应积极出席会员大会。

饶安昌表示，为会馆节省开支是一件好事，因为信件打回头也是浪费。建议提早将大会通知书寄出，如果要阅读会务报告的，可以前来本馆领取。一来既省钱，二来关注会务的会员也可以在大会前阅读完整的报告。此外也建议会馆将会务报告上传至官方网页，让不方便前来会馆的会员可以上网下载电子版。

杨博耀表示在今天修改章程的议程中会讨论这一点，若通过修改章程，以后将会务报告制作成电子版，上传至官方网站，同时也希望会员们能谅解。

杨培福指出本馆的官方网站并没有更新，更多资讯都无法在官网中获知。

杨博耀表示，部分旧信封上的网页是旧的网址，因此所登入到的可能是旧的页面。此外，本馆也会时刻注意更新官网的资料。

由杨建智提议，赵绍田附议，一致通过接纳 2021 年会务报告。

#### **4. 接纳 2021 年财政报告**

罗伟奇询问，为何会馆的收入少了，可是所得税却多了？另，也想知道法律咨询费是用在何处？

杨博耀表示在 2020 年间，租户 Plato Straits Heritage 迟缴租金，但根据对方与本馆所签订的租契，对方务必准时交租。因此本馆对该租户采取法律行动，以让对方每个月准时缴付租金。

会计师彭振文解释，会馆还所得税是根据 CP500 缴付的，若有多缴付的税务，所得税局将会于 2022 年退还。

张荣华表示，财务报告应公开所有产业，将产业列明，让会员们清楚知道所有的产业及其价值。

彭振文指出，在审计报告中的 Note 4 已经清楚列明会馆的产业价值。

由罗伟奇提议，张荣华附议，一致通过接纳 2021 年财政报告。

## **5. 接纳 2022 年财政预算案**

由杨建智提议，邬汉龙附议，一致通过接纳 2022 年财政预算案。

## **6. 讨论理事会提案：章程修改**

杨博耀表示，欲修改章程主要是配合两馆一社整合，让两馆一社的章程和理念更接近。

赵绍田询问，有关两馆一社整合，具体是怎样的概念？理事会和产业如何处理？

杨博耀强调，两馆一社只是整合，并非合并，整合后依旧保留两馆一社，依然各别拥有产业和理事会，但行政统一，此后不再分开。例如两馆一社会在同一天进行会议，一起举办活动，共同商议会务。

有关修改章程第五章第七条，张荣华认为要提供繁复的资料去证明自己是 大埔人才能加入会馆，恐怕难以吸引新生代加入。

杨博耀解释，本馆并非要刁难申请者，只是为了保障大埔同乡的福利。本馆要求证明资料只是为了确定申请者为大埔人，而非其他籍贯。至于是否能吸引新生代，他认为应努力在活动上着手，而不是在章程的字眼中作修改，例如本馆将加强电子媒体宣传和会员福利。而这两年内，申请入会的青年已经逾百位，足以证明本馆致力的方向没错。

杨培福指出，根据本馆发出的章程最后一行字注明“本华文章程为翻译本，一切以英文本为准”。若章程是根据英文版本的，那么应该将中英文版本都提呈给会员查阅和通过。此外，理事会提呈修改章程是重要之事，理应提前将修改章程的部分寄出给会员阅读，而不是当场派发。由于会员在现场才取得有关修改章程的资料，根本来不及阅读当中的内容，因此认为这对会员不公平。

杨博耀指出，根据惯例，修改章程是先通过中文章程后，然后翻译成英文版，再将英文版的章程发放给大家查阅。如果会员们发现英文翻译与中文

版本不符，可以提出修改。若不通过中文章程，根本无法送去翻译成英文版。同时，杨博耀也代表理事会向所有会员致歉，因为没有将修改章程的部分发给会员，希望会员们体谅。

杨培福认为第十章第十九条的“会员大会”应该保留“常年”二字，因为会员大会是每一年必须召开的，认为没有必要删去此二字。另，第五章第七条，建议由现任理事及协理认证即可，前任理事作介绍人即可。

杨博耀代表接纳建议，保留“常年”二字。至于“前任理事”，杨博耀指出有部分理事或许想要介绍大埔籍人士入会，因此本馆为前任理事保留作为“证明人”的权力。但尽管“前任理事”能作为证明人，申请人仍然要提呈大埔籍证明文件，理事会才会通过其会员申请。

陈伟量询问，为何会员合法妻子不得在馆内担任高职。

杨博耀反问，是否能接受非大埔籍的会员妻子或外籍妻子担任本馆主席或副主席等高职？杨博耀指出本馆为大埔籍会馆，因此有责任让大埔同乡获得优先权。杨博耀也提出将在第五章第八条中注明非大埔籍。

余秀娟提及两馆一社整合能节省时间和资源是一件好事，但认为还是需要慎重考虑是否要通过修改章程，因为大家并没有足够的时间阅读修改的部分。在未完全了解的情况下，若通过修改章程，以后大家必须共同承担修改章程所带来的后果。此外，也想询问有关两馆一社整合的缘起中提到将会成立“担保有限公司”，该有限公司是否可以进行商业活动？

杨博耀表示，在两馆一社整合后，将共同成立一个新的机构管理两馆一社，但该机构的运作绝不涉及任何商业及投资项目。由于有会员建议押后通过章程，因此需要参与大会的所有会员举手表决。

议决：82位赞同，9位反对，通过修改章程。



1. **Speech by the Chairman Yong Pock Yau**

Good morning, Council members and fellow members. Thank you very much for attending today's **【2022 Annual General Meeting】**.

Today, Char Yong Association and Chha Yong Fay Choon Kuan Association have scheduled to hold their AGM on the same day. I hoped that in the future, we can integrate the two associations into a stronger group, and jointly organize activities so that we can go further in all aspects.

On behalf of the council, I would like to sincerely thanks all the enthusiastic folks for their constant concern about the development of the association. At the same time, I also hoped that all members and folks could continue to support and participate in the activities organized by the association in the future. Thank you.

2. **To confirm & review the minutes of the AGM dated 11<sup>th</sup> December 2021**

Proposed by Chong Choo Chee and seconded by Lee Kee Choo, the minutes of the preliminary meeting were unanimously adopted.

**3. To adopt the Annual General Meeting Report for the year 2021**

Chong Yoong Fah didn't see the Guan Ti statue today, so he asked where is the statue currently?

The Chairman, Yong Pock Yau responded that the Guan Ti statue has a history of more than 70 years. The statue is attached to the Chha Yong Fay Choon Kuan Association and belongs to them. After many years, the golden body of Guan Ti statue fell off. It was therefore referred by the Guan Di Temple Chinatown to sent it to Batu Pahat for professional restoration by reapplying gold leaf. Since the restoration of the golden body can only be processed after the Ching Ming Festival, the golden body will only be sent in May. Due to the time required for repair, the golden body of Guan Di statue has not been able to be welcomed back before this AGM, but it will be welcomed back before Guan Ti Festivity.

Chong Yoong Fah hoped that the association will welcome back the golden body of Guan Ti Statue before Guan Ti Festivity.

Chow Sow Thien said that he only received the notice for the AGM and the financial report this year, but did not receive the annual report. Therefore, he asked the council why they did not mail the annual report to the member this year.

Yong Pock Yau pointed out that as early as 2015, the motion has been passed, only the notice of the AGM and financial reports will be sent out in non-election years to save postage and printing expenses.

Chow Sow Thien believed that the complete annual report should be sent out, because this is the basic right of members. If the report is not sent out, then the attendees cannot be able to understand the affairs, so it is recommended that all affairs reports be sent out.

Yong Pock Yau reminded members that if they have any proposals, they should submit them seven days before the AGM. The motion that only the notice of the AGM and financial report will be sent out in non-election years has been passed in the AGM. The association's income depends on rent and interest on bank fixed deposits, and the interest in the past two years has been getting lower and lower, so it is thought it can be saved. If the members feel that it is necessary to send out the annual report, that can be discussed again. However, at least 200 annual reports sent out during each general meeting are returned by the post office every year. If members really pay so much attention to the affairs of the association, they should actively attend the AGM.

Yew Onn Chong said that it is a good thing to save money for the association, because it is also a waste to send the letter back. He recommended sending out the notice of the AGM in advance. If someone wants to read the annual report, they can come to the association to collect it. On the one hand, it saves money, and on the other hand, members who are concerned about the AGM can read the full report before AGM. In addition, he recommended uploading the report to the official website, so that members who find it inconvenient to come to the association can download the electronic version.

Yong Pock Yau said that this point will be discussed in today's agenda for amending the constitution. If the amendment to the constitution is adopted, the annual report will be generated electronically and uploaded to the official website in the future, and he hoped that the members will understand.

Yong Poi Fook pointed out that the official website of the association has not been updated, and much information cannot be found on the official website.

Yong Pock Yau said that the webpages on some of the old envelopes are old URLs, so maybe logged into an old page. In addition, the association will always pay attention to updating the information on the official website.

Proposed by Yong Ah Yong, seconded by Chow Sow Thien, unanimously adopted.

**4. To adopt the Annual Financial Report 2021**

Loh Wei Chyi asked why is the association's income tax increasing when the revenue is decreasing? Other than that, he also wanted to know where the legal consultation fee is used?

Yong Pock Yau answer that the tenant Plato Straits Heritage is late in paying rental during 2020, but according to the lease signed between them and the association, they must pay the rental on time. Therefore, the association took legal action against the tenant to get the other party to pay the rental on time every month.

The accountant, Phang Cheng Boon explained that the association's income tax is paid based on CP500. If there is overpaid, the LHDN will refund it in 2022.

Chong Yoong Fah said that the financial report should disclose and list all the properties so that members can clearly know all the properties and their values.

Phang Cheng Boon pointed out that the value of the association's properties has been clearly stated in Section Note 4 of the audit report.

Proposed by Loh Wei Chyi, seconded by Chong Yoong Fah, the annual financial report 2021 was unanimously adopted.

**5. To adopt the Proposed Financial Budget for the year 2022**

Proposed by Yong Ah Yong, seconded by Woo Hon Long, the budget for the year 2022 unanimously adopted.

**6. To review Council Members proposal: Constitution Amendment**

Yong Pock Yau said that the main reason for amending the constitution is to cooperate with the integration of Char Yong Association, Chha Yong Fay Choon Kuan Association and Cha Yong Li Chee Association, so that the constitution and philosophy can be brought closer together.

Chow Sow Thien asked what exactly is the concept regarding the integration of the three associations? How about the council and the property?

Yong Pock Yau emphasized that the three associations are only integrated, not combined. After the integration, they will be retained, each with their own property and council, but the administration will be unified and will not be separated thereafter. For example, three associations will hold meetings on the same day, hold activities together, and discuss affairs together.

Regarding the amendment of Article 7 of Chapter 5 of the constitution, Chong Yoong Fah believed that it would be difficult to attract the new generation to join the association, if complicated information needed to be provided to prove that they are Dabu clans.

Yong Pock Yau explained that the association is not trying to make things difficult for the applicants, but only to protect the welfare of our fellow villagers in Dabu. The association requires proof information only to confirm the applicant is Dabu clans. As for whether it can attract the new generation, he believed that efforts should be made to start with activities, rather than making changes in the wording of the constitution. For example, the association will strengthen the electronic media campaign and membership benefits. In the past two years, more than 100 young people have applied for membership, which is enough to prove that the association is committed in the right direction.

Yong Poi Fook pointed out that according to the last line of the constitution issued by the association, it is stated, "This Chinese version of Constitution is a translated copy, in the event of any discrepancies, the English version shall prevail". If the constitutions are based on the English version, then both the Chinese and English versions should be submitted to the members for review and approval. In addition, the Council's proposal to amend the constitution is an important matter. The revised parts of the constitution should be sent to members in advance for reading, rather than distributed on the spot. Since the members only obtained the information about the revision of the constitution on the spot, they had no time to read the contents. Therefore, it was unfair to the members.

Yong Pock Yau pointed out that, according to the usual practice, the amendments of the constitution are adopted in Chinese and then translated into English before the English version is distributed for inspection. If the members find that the English translation does not match the Chinese version, they can propose an amendment. If the Chinese version of the constitution is not passed, it will not be able to translated into English. At the same time, Yong Pock Yau also apologized to all the members on behalf of the council for not sending out the revised part of the constitution to the members. He hoped the members could understand this.

Yong Poi Fook said that the word "Annual" of "General Meeting" in the Article 19 of Chapter 10 should be reserved because the general meeting must be held every year, the deletion of this word was not considered necessary. In addition, for Article 7 of Chapter 5, it is suggested that certification by the current director and associate is sufficient, with the former director serving as the introducer.

Representative Yong Pock Yau accepted the proposal and reserved the word of "annual". As for "Former director", Yong Pock Yau pointed out that some directors may want to introduce Dabu citizens to join the association, so the association reserves the power of former directors as "Verifier". Despite the "former director" as a verifier, the applicants still have to submit proof of Dabu clan before the council will approve their membership application.

Chan Wooi Leong asked why a member's legal wife was not allowed to hold a senior position in the association.

Yong Pock Yau asked rhetorically whether it was possible to accept non-Dabu members' wives or foreign wives to take up senior positions such as the president or vice-president



of the association? Yong Pock Yau pointed out that the association is a Dabu Clans association, so it is responsible to provide priority to fellow Dabu clans. Yong Pock Yau also proposed to specify non-Dabu membership in Article 8 of Chapter 5.

Yee Shew Juan mentioned that it is good that the integration of three associations saves time and resources, but she believed that careful consideration still needed to be given to the adoption of the changes to the constitution, as people did not have enough time to read the amended sections. If the amendments to the constitution are passed without fully understanding, everyone must jointly bear the consequences of the amendments in the future. Other than that, she also wanted to ask regarding the establishment of "Guarantee Co., Ltd" as mentioned in the origin of the integration of the three association. Can this company carry out commercial activities?

Yong Pock Yau said that a new organization will be jointly established after the integration of three association to manage them, but the operation of the organization will never involve any commercial and investment projects. Since some members suggested postponing the adoption of the constitution, all members participating in the AGM are required to vote by show of hands.

Resolution: 82 agreed, 9 objected, the amendment of constitution is adopted.

**1 SIGNIFICANT ACCOUNTING POLICIES 账目准则**

The principal accounting policies adopted are set out below:

**1.1 PLANT AND EQUIPMENT 机件与设备**

The cost of an item of plant and equipment is recognised as an asset when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. After recognition as an asset, an item of plant and equipment are measured at cost less any accumulated depreciation and any accumulated impairment losses.

Depreciation is provided on a straight line method so as to write off the depreciable amount of the following assets over their estimated useful lives, as follows:

**1.2 INVESTMENT PROPERTIES 物业投资**

Investment property which is held to earn rentals or for capital appreciation or both, is measured initially at its cost. Transaction costs are included in the initial measurement.

After recognition as investment property, items of investment property whose fair value can be measured reliably without undue cost or effort are measured at fair value at each reporting date with changes in fair value recognised in profit or loss. If a reliable measure of fair value is no longer available without undue cost or effort for an item of investment property measured at fair value, it is thereafter account for as property, plant and equipment in accordance with Section 17 of the PERS. The carrying amount of the investment property on that date becomes its cost.

Property interest held under operating leases are not classified and accounted for as investment property.

### 1.3 IMPAIRMENT OF ASSETS 资产减值

At each reporting date, the Association assesses whether there is any indication that an asset may be impaired. If any such indication exists, the recoverable amount of the asset is estimated.

When there is an indication that an asset may be impaired but it is not possible to estimate the recoverable amount of the individual asset, the Association estimates the recoverable amount of the cash-generating unit to which the asset belongs.

The recoverable amount of an asset and a cash-generating unit is the higher of the fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

If the recoverable amount of an asset or a cash-generating unit is less than the carrying amount, an impairment loss is recognised to reduce the carrying amount to its recoverable amount. An impairment loss for a cash-generating unit is firstly allocated to reduce the carrying amount of any goodwill allocated to the cash-generating unit, and then, to the other non-current assets of the unit pro rata on the basis of the carrying amount of each appropriate asset in the cash-generating unit. Impairment loss is recognised immediately in profit or loss, unless the asset is carried at a revalued amount, in which case it is treated as a revaluation decrease.

The recoverable amount is the higher of an asset's or cash-generating unit's fair value less to sell, value in use and zero.

An impairment loss recognised in prior periods for an asset or the appropriate assets of a cash-generating unit is reversed when there has been a change in the estimates used to determine the asset's recoverable amount. An impairment loss is reversed to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation, if no impairment loss had been recognised in prior periods. A reversal of an impairment loss is recognised immediately in profit or loss, unless the asset is carried at revalued amount, in which case it is treated as a revaluation increase.

### 1.4 CASH AND CASH EQUIVALENTS 现金和现金等价物

Cash and cash equivalents in the statement of cash flows comprise cash and bank balances, short-term bank deposits and other short-term, highly liquid investments that have a short maturity of three months or less from the date of acquisition, net of bank overdrafts.

### 1.5 INCOME 收入

i) *Rental Income* 租金收入

Rental income is recognised over the period of the tenure.

ii) *Interest Income* 利息收入

Interest income is recognised on accrued basis.

iii) *Donation and Member Subscription Received* 捐款及会员入会收入

Donation and member subscription received are recognised on a receipt basis

## 1.6 EMPLOYMENT BENEFITS 雇员福利

### i) *Short-Term Employment Benefits* 短期雇员福利

Short-term employment benefits, such as wages, salaries and other benefits, are recognised at the undiscounted amount as a liability and an expense when the employees have rendered services to the Association.

The expected cost of accumulating compensated absences are recognised when the employees render services that increase their entitlement to future compensated absences. The expected cost of non-accumulating compensated absences, such as sick and medical leaves, are recognised when the absences occur.

The expected cost of accumulating compensated absences are measured at the undiscounted additional amount expected to be paid as a result of the unused entitlement that has accumulated at the end of the reporting period.

The expected cost of profit-sharing and bonus payments are recognised when the Association has a present legal or constructive obligation to make such payments as a result of past events and a reliable estimate of the obligation can be made. A present obligation exists when the Association has no realistic alternative but to make the payments.

### ii) *Defined Contribution Plan* 规定的缴交方案

Contributions payable to the defined contribution plan are recognised as a liability and an expense when the employees have rendered services to the Association.

## 2 CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY 重要会计判断及估计不确定因素的主要来源

### 2.1 CRITICAL JUDGEMENTS IN APPLYING THE ACCOUNTING POLICIES 重要会计判断

In the selection of accounting policies for the Association, the areas that require significant judgements and assumptions are in (a) classification of finance and operating lease (b) the classification of a property as an investment property or plant and equipment.

### 2.2 KEY SOURCES OF ESTIMATION UNCERTAINTY 估计不确定因素的主要来源

The key assumptions concerning the future, and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next year, other than those disclosed in the Notes, are as follows:

#### i) **Depreciation of Plant and Equipment** 机件与设备折旧

The cost of an item of plant and equipment is depreciated on the straight-line method or another systematic method that reflects the consumptions of the economic benefits of the assets over its useful life. Estimates are applied in the selection of depreciation method, the useful lives and the residual value. The actual consumption of the economic benefits of the plant and equipment may differ from the estimates applied.

**11 EVENT AFTER THE REPORT PERIOD 报告期后所发生之事项**

The global pandemic outbreak of Covid-19 remained after the financial year end. The Covid-19 pandemic continues to adversely affect the global economy including the regional economies in which the Company operates.
